SHIKSHA MANDAL: AN OVERVIEW

HISTORY:

Shiksha Mandal is a century old institution based at Wardha, the undeclared intellectual capital of pre-Independence India. Founded by Shri Jamnalal Bajaj, it was deeply influenced by freedom struggle and Gandhiji. Its faculty and students were involved in freedom movement and one of the institutions was closed by the British. In fact, the nation's first education conference was held in Shiksha Mandal in 1937, at which Gandhiji presided. The idea of Nayee or Buniyadi Talim arose from this conference.

Starting with a student hostel, it established a school at Wardha in 1919. It moved to higher education in 1940 when its Commerce College was established at Wardha. In 1945, a Commerce College was established at Nagpur, followed by a Science College at Wardha in 1962. In 1961, a Rural Institute was established at Wardha, which offered courses in Economics, Agriculture and Engineering. This was later spun into three different institutions in these disciplines. In 2003, an Agriculture college was started in Wardha. The latest addition to this list is Bajaj Institute of Technology which was launched in 2017-18. All but one institutions of Shiksha Mandal have been rated as 'A' grade by external agencies. In 2015, it was awarded the first "Ideal Educational Institution Award" of the RTM Nagpur University. Shiksha Mandal has a culture of excellence, discipline, hard work, simplicity, social commitment and ethical behaviour. In short, it is committed to producing Industry- ready professionals and good human beings, who will innovate and deliver.

The Presidents of Shiksha Mandal have been from the Bajaj family. Shri Rahul Bajaj, Chairman, Bajaj Auto Ltd., is its current President.

Shiksha Mandal celebrated 2014-15 as its centenary year. The centennial ceremony held on 26th November 2014 at Shiksha Mandal's Wardha headquarters was graced by the Hon'ble President of India, Shri Pranab Mukherjee who, while acknowledging Shiksha Mandal's significant contribution to the society over a century, expected it to play a definitive role in nation building by taking education to new levels of excellence. The ceremony was also graced by the Governor of Maharashtra Shri Ch. Vidyasagar Rao, Chief Minister of Maharashtra Shri Devendra Fadnavis and the Union Minister Shri Nitin Gadkari, also our alumnus, in the august presence of Shri Rahul Bajaj, President, Shiksha Mandal.

The normal medium of instruction is English. But in our Commerce colleges sections are also run in Hindi

and Marathi mediums. All its institutions are set on sprawling campuses with good infrastructure. Most of its institutions are affiliated to R.T.M. Nagpur University. 6 of its 8 institutions are aided.

Shiksha Mandal's drive for qualitative growth of its colleges is reflected through their accreditation ratings. Three of its colleges, including G. S. College of Commerce & Economics, Nagpur, have been rated with 'A'-Grade by National Accreditation and Assessment Council (NAAC). Its Bajaj College of Science, in addition to its NAAC 'A'-Grade, has been rated as a College with Potential for Excellence by the University Grants Commission (UGC) and is the only College in Vidarbha to have been awarded the Department of Biotechnology's Star College Scheme. Its Ramkrishna Bajaj Agriculture College is rated as 'A' by its affiliating Panjabrao Dekhmukh Agriculture University and its Engineering Polytechnic has been rated as "Excellent" by Maharashtra State Board of Technical Education. S. J. Grameen Seva Mahavidyalaya, Pipri-Wardha was accredited with an 'A'-Grade by NAAC in 2017. Its Bajaj Institute of Technology (BIT) Wardha, in its fourth year now, has succeeded in exhausting its full intake capacity without any advertisement or fanfare and has now become one of the most preferred Engineering Colleges in the region. Two of its colleges, Bajaj College of Science and G.S. College, Nagpur have already been conferred with Autonomous status by the UGC while other colleges are gearing for Autonomy.

These two colleges are also the recipients of MHRD's RUSA grants of TWO CRORE each.

It has excellent library facilities in all its colleges, with the libraries at its Science College at Wardha and Commerce College at Nagpur having over 65,000 books. Broadband internet connectivity and Computer Laboratories and language labs exist in all of its colleges. Currently, it has almost 10,000 students on its rolls, of which around 52% are female. Out of over 300 teaching faculty over 60 are Ph.D.'s. Shiksha Mandal prides itself as an institution which women, students and faculty prefer.

It offers courses from Class XI to Ph.D. Besides traditional aided courses, it has over the years added non-aided courses including MBA in its institutions. Committed to development of its students, Shiksha Mandal offers many add-on and certificate courses to them. These include courses in Computer and in English. Guidance for competitive and professional examinations, like Chartered Accountancy and Company Secretary is also provided.

A strong tradition of National Service Scheme, National Cadet Corps, Sports and Extra-Curricular activities exists. Shiksha Mandal has also been involved in rural development for the last 40 years. Since 1984, it has been running a Community Polytechnic Scheme of vocational training very successfully.

Shiksha Mandal's students regularly feature in merit lists for accomplishments in academics and also bring laurels in Sports and extra-curricular activities. Its eminent alumni include the Late Shri Madhukarrao Chaudhari (ex-Speaker of Maharashtra Assembly); Shri Harish Salve, former Solicitor General of India; Shri Nitin Gadkari, Union Minister of Highways; Shri Banwarilal Purohit, Governor of Tamil Nadu; Shri Jaydeep Shah, ex-President of ICAI; Shri Ramesh Chandak, MD, KEC International among others.

Shiksha Mandal's ceaseless drive for achieving academic excellence and its transparent practices in educational management have been acknowledged by RTM Nagpur University when it conferred upon Shiksha Mandal its inaugural 'Ideal Education Institute Award' for the session 2014-15.

AUTONOMY : 3 YEARS ON...

G.S. College of Commerce & Economics, Nagpur, which came into being in 1945 as the City's first Commerce College, has from the beginning always enjoyed a reputation as a premier Commerce College in the region not only because of its consistent curricular, co- and extra-curricular performances, or its rich alumni profile, but also because of its innovative approaches to Commerce Education which had given shape and substance to the Nagpur University's Faculty of Commerce in the last century.

The new century brought in new ideas which pervade all spheres of life and suddenly it became obvious that Education, especially Higher Education, needed to be more innovative, more challenging and more meaningful to cope up with demands of the new century. Shiksha Mandal, Wardha, which had witnessed the whole of 20th century, from 1914 to be precise, also welcomed the new century with a new vision. Always alive to the demands of stakeholders, it realized that the traditional University curricula do not really incorporate the latest knowledge nor are the present teaching-learning methodologies adequate enough to mould students on the desired lines.

Differently put, we disseminate in the name of knowledge a syllabus, which at best could be described as too limited, and, at worst, as too inflexible and outdated. It seldom does incorporate the most current and the most relevant, not because it is intended as such but because it cannot be otherwise owing to the prevalent university systems of framing syllabi of various courses. This creates, firstly, a huge gap between what the students really want and what they are actually given in classrooms, and, secondly, they fall short of expectations of the industry/ job market which thrives on the latest and the updated.

The most relevant courses and foolproof systems of evaluation along with the usage of modern teaching-learning methods and use of ICT have now become the necessities, rather than exceptions, of higher education scene in India. Especially in Commerce, where things are often fluid, the syllabi need to be constantly updated if not revised. The present university systems, unfortunately, do not have that flexibility.

UGC's Scheme of Autonomy offers some concrete solutions to these issues. Firstly, autonomy bestows upon an institution the freedom of conducting and designing the courses which may or may not be conducted by the university. Secondly, it grants to institution the freedom to implement its own evaluative mechanism in consonance with the UGC guidelines. With these two measures at disposal, teachers can indeed mould students to their hearts' desires and industry's expectations, and carve out successful professionals out of them.

Shiksha Mandal, ever committed to providing quality education to its students thus resolved to make its colleges autonomous for better fulfillment of its mission and now two of its colleges, Bajaj College of Science (formerly J. B. Science College), Wardha and G. S. College of Commerce & Economics, Nagpur, are already autonomous.

To perform its new responsibilities as an autonomous college, G. S. College of Commerce & Economics, Nagpur, made extensive preparations. It re-designed its existing courses and also designed two new degree programmes of B.Com. (Honours) and B.Com. (Finance & Accountancy) which got underway from 2020-21 session. Our teachers have already visited some renowned autonomous institutions in the country like St. Xavier's and KJ Somaiya in Mumbai, and Christ University, Bangalore and studied their systems. It has already constituted its Governing Body, Academic Council and Boards of Studies as per the UGC Guidelines and finalized its methods and procedures for the smooth implementation of autonomy.

Autonomy has allowed us to upgrade the existing syllabi, start new courses, and thus equipped us to make our students better suited for their careers. More importantly, it has enabled us to add high quality to examination system in terms of question papers and assessment mechanism. Control over examinations shortens the time spent on examinations which not only increases the academic input but also allows results to be announced well in time.

There were general apprehensions that Autonomy would lead to dilution of academic standards and sharp increase in fees. In our case, neither has happened.

Now after 3 Years of Autonomy, the first batches of our UG and PG programmes are out and they are ready for their first ever autonomous degrees, which shall proudly bear the college's name even as they would be issued by the Hon'ble Vice-Chancellor of the RTM Nagpur University.

By opting for Autonomy, we have subjected ourselves to some legitimately high standards of accountability. Backed by moral and professional integrity of our faculty, we wish to place this institution on par with the most sought-after autonomous colleges in the country for sheer employability of students.

In order to realize this goal, students, too, have to perform their roles. They have to be very regular, disciplined, sincere and hard-working for reaping the benefits that autonomy offers. Students should know that autonomy is meant to make a difference in their careers. But tough syllabi and tougher schedules also make it a challenge. However, as is well said, the tough get going when the going gets tough.

And we mean to make our students tough through our autonomy.

- Teaching Hours:** The college conducts its programmes in two shifts as per the following details:
 - Senior college** (all UG and PG programmes): 8:20 a.m. - 3:00 p.m.
 - Junior college** (FY/SYJC & M.C.V.C): 8:20 a.m. - 3:00 p.m.
- Office Hours:** The College office works from 10:30 a.m. to 6:00 p.m. However, changes may be made in these timings according to the needs of college and notifications from Government authorities. The College office functions for half day on every Saturday.
- College Uniform:** To promote a feeling of oneness among students and for disciplinary reasons, the college has prescribed a uniform for its students of both Junior and Senior wings as described below:

BOYS: White Terrykot shirt/ Grey Terrykot trousers; Grey Sweater/ Coat during winter.

GIRLS: White Terrykot Kurta / Grey Terrykot Salwar / Grey Chunri; Grey Sweater/ Coat during winter.

Black shoes and white socks for both boys and girls. Jeans/T-shirts/ skin tights etc. are not allowed.

GENERAL RULES / NORMS FOR ADMISSIONS: SENIOR COLLEGE (Grant-in-aid & No-Grant)

(A) Intake/Quotas/ Reservations etc.

The College has been accorded the status of "Hindi Linguistic Minority Institute" by the Government of Maharashtra.

As such, 50% seats of all grant-in-aid programmes viz. B. Com. and M. Com. and 51% seats of all no-grant programmes viz. B.Com., B.Com. (Computer Applications), B.B.A., B.Com. (Honours) & B.Com. (Finance & Accountancy) are reserved for students from Hindi speaking communities as listed in the Eighth Schedule for Languages subject to the condition of domicile in Maharashtra State and on production of an affidavit on a Rs. 100/- stamp paper that they belong to the Hindi Speaking Communities as listed in the Eighth Schedule for languages in the Constitution of India. Students from other linguistic/religious minority can also apply against minority quota subject to vacancies in the Hindi minority quota. The rest of the seats will be filled from among the candidates from non-Hindi speaking students with due reservation for various categories viz. SC/ST/VJNT/OBC-SBC / EWS etc. strictly on merit basis.

GENERAL RULES / NORMS FOR ADMISSIONS: SENIOR COLLEGE

(B) Procedure for Admission:

- All admissions to all the courses are carried out strictly on merit basis and as per the directives by the Department of Minority Development, Government of Maharashtra, and RTM Nagpur University and as per the college's admission policy as stipulated in its Direction No. 2 of 2020.
- All admissions against Minority, Open, and other Categories will be carried out as per the notified schedules. However, the college reserves the right to effect necessary changes in the schedules, if necessary.
- A Student has to fill the prescribed Registration/Application Form for admission in his/her handwriting. The form is attached to the Prospectus. Students should not use any unnumbered or photocopied form.
- Information furnished in the admission form must be true. Admission is liable to be cancelled if any information is found to be false and/or incorrect.
- Application form must be countersigned by a Parent/Guardian, and it should be accompanied by the following documents:

IMPORTANT COLLEGE COMMITTEES / CELLS / STUDY CIRCLES

The college has set up various college committees for the conduct of all curricular, co-curricular, and extra-curricular activities. Similarly, there are also committees to offer guidance/counseling to our students, or to redress their grievances. The committees are headed by teacher-conveners/coordinators. Students are advised to contact the conveners for participating in activities, or for any other queries related to their studentship and other problems.

- **Anti-Ragging/ Caste Discrimination / Grievance Redressal Cell:** As per the directives of the Supreme Court of India and the UGC, Ragging and Sexual Harassment are to be treated as crimes and thus punishable after prosecution. Students are advised to report any incidents of ragging or harassment or Caste Discrimination without any inhibition or fear to the Committee in person or on phone. **There is also an All-India Helpline (1-800-180-5522) for reporting crimes related to Ragging.**
- **Students Representative Council (SRC):** Every year, and as per the instructions and guidelines given by RTM Nagpur University, the college constitutes the SRC consisting of the class /activity representatives. These members elect from amongst themselves a College Representative to the University's Students Council. The SRC is responsible for the conduct of all extra-curricular activities like debate/ elocution/essay/cultural and other competitions and the annual festival 'Umang'.
- **Girls Guidance and Counselling / Internal Complaints Committee:** This committee is constituted to solve the girl students' academic and personal problems through proper counselling. The committee also organizes special interaction sessions by lady doctors, professionals/entrepreneurs etc. for counseling the girls on health and hygiene or proper careers. There is also separate Internal Complaints Committee to deal with the sexual harassment issues.
There is also a Police Helpline (1091) for reporting cases of Sexual Harassment.
- **Internal Quality Assurance Cell (IQAC):** Our college has always been quality conscious and has, after its first accreditation in 2003, set up an IQAC. The IQAC has for its members the representatives of our management and academicians who plan for an all-round development of the college.
- **College Examinations/Internal Assessment Committee:** The college puts premium on the continuous internal assessment of our students. This committee plans and organizes all internal examinations and viva-voce. Students are advised to watch out for examination schedules/notices as issued by the Committee. The college has also set up a separate Autonomy Examination mechanism.
- **Career Guidance and Placement Cell:** This Cell guides the students for choosing the right career and also gives information about the employment opportunities in business and industry. It organizes seminars and Guest lectures to apprise students of emerging professional trends and events, job profiles, leadership roles, entrepreneurship, market needs and risks, national socio-economic policies etc. It also organizes sessions for soft skills and campus interviews. In the past, our students have got placements in reputed companies like J.P. Morgan Chase, Progeon Infosys, Birla Group, Mahindra Finance, Ambuja Cement, TCS, L&T, KEC, Muthoot Finance, Wipro, Concentrix etc. Last year, placement drives were not conducted owing to COVID-19 pandemic.
- **Student Mentorship Scheme:** This scheme is intended to establish a close rapport between students and teachers who act as mentors for a batch of select students from their entry to exit from the college.
- **Student Feedback/ Parent-Teacher Meet Committee:** The college has got a very active feedback mechanism. The feedback collected from all stakeholders is used for formulating academic and administrative policies. We also conduct Parent-Teacher Meets to get feedback from parents and for sharing with them their wards' progress.
- **College Magazine Committee:** The college publishes every year an in-house magazine "Rashtradhan". It is meant to be a documentation of our students' creative talents as well as the reflection of their thoughts and views on various economic, social, and political issues in the country. Students are expected to contribute to the magazine with their original write-ups instead of resorting to plagiarized material which will be rejected.
- **Shiksha Mandal Guidance Bureau:** In order to apprise our students of the new and latest developments in different fields of Commerce, Economy, Banking, Insurance, Finance etc, Shiksha Mandal has set up a Guidance Bureau. The Bureau also guides students about the opportunities, potential, and latest information, knowledge and techniques pertaining to various subjects beyond those covered by syllabus.
- **Student Welfare / Counselling Cell:** The College offers various welfare schemes in the form of scholarships and aids. Students willing to avail these schemes should contact the Professor-in-charge/Mentors for details. Students are also advised to approach the Cell for solving their problems through professional counselling. The Cell also ensures that provisions contained in UGC (Promotion of Equity in Higher Education Institutes) Regulations, 2012 are observed in spirit and letter by all the stakeholders of the college.

PLACE OF HIGHER LEARNING AND RESEARCH

The College has been granted recognition as a 'Place of Higher Learning and Research' by RTM Nagpur University in the subjects of Business Economics, Commerce and Management in the Faculty of Commerce. The Students aspiring to do Ph. D. in Commerce can enroll in the College and avail the facilities.

The College also has registered Ph. D. supervisors who guide the aspiring research students.

The College provides the following facilities:

- A Network Resource Centre (NRC)/SPSS Software.
- Research Methodology workshops for the registered students.

GS-SKILL UPGRADATION NETWORK (GS-SUN)

The College has introduced from the session 2013-14, a special skill building programme for students of Senior college called as the 'GS Skill Upgradation Network - GS- SUN'. The training programme has the following objectives:

- To provide to students practical training by exposing them to Business/ Industry through a network of Alumni.
- To enable students to get a first hand feel of Job complexities in the competitive world outside.
- To groom students to acquire Communication and ICT skills.

The Programme is implemented in the following phases:

A) Pre-internship grooming: Since students selected for internships will have to spend minimum of 12-14 months with the professionals/corporate, it is imperative that they should be given a pre-internship training for acquiring those skills which are the pre-requisite qualifications for a good internship programme. We therefore conduct a six-month Grooming Programme at the UG/PG level for all Part I students. This involves training for the acquisition of communication skills and proficiency in ICT, computerized accounting, e-filing of all tax returns etc. This training will help students to learn more once they are into actual internships.

Students selected for this programme have to deposit Rs. 2000/- towards caution money which will be refunded to them only after the successful completion of their internship terms.

B) Practical training/internship: Those students who successfully complete the Grooming Programme would be shortlisted for internship. The duration of practical training/internship will be 12-14 months spread over two sessions of Part II & Final (UG) and over two semesters of PG. The timings for internship terms will be from 11.30 a.m. to 5.30 p.m. Students may also be offered stipends from their respective firms/college.

C) Placements: All those student-internees who successfully complete their internship terms may be absorbed by their respective employers. The college also recommends to reputed companies the names of deserving candidates for placements during campus recruitment.

DEPARTMENT OF MANAGEMENT SCIENCES AND RESEARCH (DMSR)

The college offers a two-year (four-semester) MBA (Autonomous) programme on self-financing basis. The course is affiliated to the RTM Nagpur University, Department of Technical Education, Government of Maharashtra, and AICTE. We have a separate Department of Management Science and Research (DMSR) which conducts the M.B.A. (Autonomous) programme. The Department boasts of a very competent infrastructure at **Bajaj Bhavan** where all necessary facilities are provided to students. We have highly qualified and experienced faculty who monitor all academic and extra-curricular activities in the Department. We regularly conduct the campus interviews and our students are recruited by top companies.

(A) Intake/Quotas/ Reservations

The college runs a full-fledged Junior College (FYJC and SYJC) in Commerce from 1975 and also a wing for H. Sc. (Vocational)/MCVC in English, Hindi, and Marathi mediums. The college enjoys a phenomenal track record in terms of results and merit positions. We also offer to our students wide range of extra-curricular activities including NSS and NCC.

The College has been accorded the status of "Hindi Linguistic Minority Institute" by the Government of Maharashtra. As per the provisions, a Linguistic Minority Institute has to reserve 50% seats in all Grant-in-aid sections for students belonging to the Hindi Minority Communities as listed in the Eighth Schedule for Languages subject to the condition of domicile in the State of Maharashtra and on production of an affidavit on a Rs. 100/- stamp paper that they belong to the Hindi Speaking Communities as listed in the Eighth Schedule for Languages.

The rest of the seats will be filled from among the candidates from non-Hindi speaking students with due reservation for various categories viz. SC/ST/VJNT/OBC-SBC strictly on merit basis.

DISCIPLINE AND CONDUCT

- Each student must report to the college in the prescribed uniform and wear without fail the identity card. A student without Uniform and Identity Card will not be allowed inside the premises.

- **It is mandatory for all students to have minimum 75% attendance in every subject in order to be eligible for appearing in the University/ Board Examinations. Students not fulfilling this condition will be detained from appearing in the Examinations. In case a student has to remain absent for long period for whatever reasons, he or his parent/guardian must intimate the college in writing and seek prior permission for the intended absence.**
- All students of both Junior and Senior College are required to appear for all unit tests/ terminal examinations, viva-voce, and also submit, whenever required, home assignments, projects etc. for their internal assessment.
- It is mandatory for students to complete their coursework including unit tests/terminal examination/home assignments/projects etc. The students failing to comply with the above shall lose their internal assessment marks.

- Students found to be indulging in activities which are not in the interest of the college and which are detrimental to the smooth functioning of the college shall be appropriately punished.
- Every student shall make proper use of college buildings, furniture, equipment, electricity/water and other facilities. Any student found guilty of causing damage or disfigurement to the college property, or found guilty of sticking posters on walls, or writing unwarranted things on the blackboards, will be straightway expelled, and the cost of damage to property will be recovered from him. Other general losses and damage to the college property shall be assessed at the end of the session and recovered from students of all classes collectively.
- All important notices, instructions etc. are put up on the College Notice Boards/ College website. Students should make a habit of visiting the Notice Boards/website regularly for important instructions and announcements.
- No student shall approach the Print or Electronic media for matters pertaining to the college without prior approval of the Principal. Any breach of this rule will lead to disciplinary action against the concerned student.
- A student suffering from any infectious or contagious disease shall not attend college. He/she will report only after declared medically fit, and on production of Medical Fitness Certificate by a Registered Physician.
- Students should inform the college authorities in writing about any change in permanent or local address, or phone number.
- Consumption of alcohol, smoking, chewing tobacco, or consuming tobacco related products on campus is strictly prohibited. Students indulging in the same will be fined and, if necessary, expelled from the college.
- **Ragging or similar such act causing physical or mental agony to fellow students will be treated as a criminal offence and students found to be indulging in the same will be liable for prosecution.**
- **Sexual Harassment in any form will not be tolerated and those involved shall be liable for prosecution.**
- **Students also shall not engage in any act of discrimination against fellow students on the basis of caste, gender, creed, colour, race, religion, place of birth, political conviction, language, and disability.**
(No cases of Ragging or Sexual Harassment or Discrimination etc. have been reported during the last academic session.)

The above rules are subject to change, modification, addition, omission, or alteration as and when the authorities deem it fit and proper. The decision of the Principal in this regard will be final and binding on all students.
