Technology (BCCAC 1.4), Operating System and Computer Hardware & Networking (BCCAC 2.3), Core Java (BCCAC 5.3) & Python (BCCAC 5.4).

- d. A subject, Computer Application in Business (CAB) (BCCASFC 3.0) (Tally), is in the Commerce Board, but as per the contents, it should be in the Information Technology Board. We discussed the issue with Prof. Akash Jain, who is the Secretary of the Academic Council, and he discussed it with the Chairman, Commerce Board, and conveyed to us to add this subject to the Information Technology Board. We discussed with the IT Board members and they agreed to add the subject to the IT Board.
- e. The Tally Company has recently launched the new version of TallyPrime. As a result, in the subject of Computer Applications in Business (BCCASFC 3.0), we upgraded the syllabus to use TallyPrime rather than Tally ERP. The committee members unanimously approved the changes.
- f. We identified some more subject reference books and conveyed them to Dr. P.M. Paradkar, the Librarian, to purchase.
