  - d. Ensure that syllabi of subjects under their respective Board of Studies are free from any plagiarism.

- 1. Prof. Akash Jain, Secretary, requested Prin. Dr N.Y. Khandait to chair the meeting.
- 2. Prin. Dr N.Y.Khandait, Chairman, welcomed all the members and invited Prof. Akash Jain to read out the agenda.
- 3. Prof. Akash Jain read out the agenda and informed that various Boards of Studies in their meeting on 12.07.2022 have effected some revision/modifications in the syllabi of various subjects under their respective Boards in order to incorporate certain cross-cutting issues relevant to professional ethics, gender, human values, environment and sustainability; revision/modifications in the overlapping of syllabi of various subjects; revision of syllabi to accommodate subjects units covering the local, national, regional and global developmental needs.
