(REGARDING CHANGE IN QUESTION PAPER PATTERN OF SEMESTER END EXAMINATIONS/SUPPLEMENTARY EXAMINATIONS FOR ALL UG NON-NEP PROGRAMME OF B.COM., B.C.C.A., B.B.A., B.COM. (HONORS), B.COM. (F&A) AND PG PROGRAMMES OF M.COM. AND M.B.A.)

G. S. College of Commerce and Economics, Nagpur has been granted autonomy by the University Grants Commission (UGC) and the RTM Nagpur University, Nagpur, from the session 2018-2019. As an autonomous college, the college has the mandate to decide its scheme of external, internal examinations and question paper pattern. Accordingly, the college has conducted till date the Semester End/Supplementary examinations as per the question paper pattern described in college's Academic Regulations issued from the session 2018-2019 and Revised Academic Regulations issued from the session 2020-2021.

The college has always reviewed the process of examination and results for monitoring the performance and growth of students. During review discussions with paper setters/ valuers /moderators/ subjects teaches and students regarding the existing examination question paper pattern, a need was felt to modify the existing question paper pattern. The internal members of the BOS of the college discussed it in their meetings and reframed a new question paper pattern for subjects under BOS of Commerce, Economics, Accounts & Statistics, Business Administration & Management, excluding the subjects under BOS of IT and Language Boards. It was put for approval in the BOS meeting (inclusive of external members) on dated 23-05-2023 and the BOS of the above boards approved it.

Accordingly the college has decided to implement/ adopt the following question paper pattern for all the NON-NEP programmes UG and PG from the session 2023-2024.
