Reports for the session 2022-23

Prof. A.S Jain

During the academic session 2022-2023, various student centric methods such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences. They are as follows:

- 1) During the year various practical sessions are conducted on the topics such as Registration Procedure under Goods and Service Tax to explain students the actual problems faced by the dealer while obtaining registration under the said Act. Various tutorials issued by GST Network are used to explain the step-by-step process of registration in classroom.
- 2) In the subject of Computer Application in Business, students are made aware about the importance of Permanent Account Number (PAN) and the procedure for obtaining PAN number offered by Income Tax Department. For giving a practical exposure of this, a live application for PAN number is made in the classroom. The details of students such as AADHAR Number and other required details are collected and the application for PAN of the student is made live in the class. Later, the PAN Card received by the student via post is shown to the students for their understanding. Assignment has been given to the students for application of their own or of any of their family member's PAN Card and note down the step-by-step procedure for application of PAN Card.
- 3) Guest lectures of subject matter experts are organized in order to facilitate students with subject specific knowledge.
- 4) Guest lectures of our alumni working in corporates are organized so that students get to know the recent trends in the industry and help them to decide appropriate domains for shaping their careers.
- 5) Sessions are conducted to discuss the recent events such as Union Budget, so that students should be aware about the recent developments in the economy.
- 6) Practice problems are solved for the practical subjects like Indirect Taxes in the virtual classes.
- 7) For subjects such as Direct Taxes, case laws are discussed and explained in the virtual classes. Sessions are conducted to explain e-filing of Tax returns.

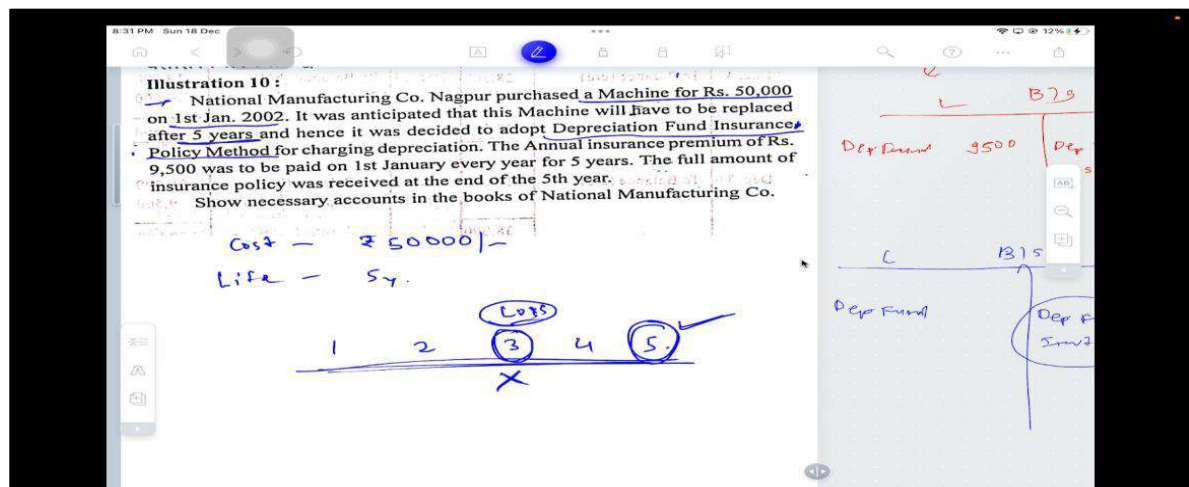
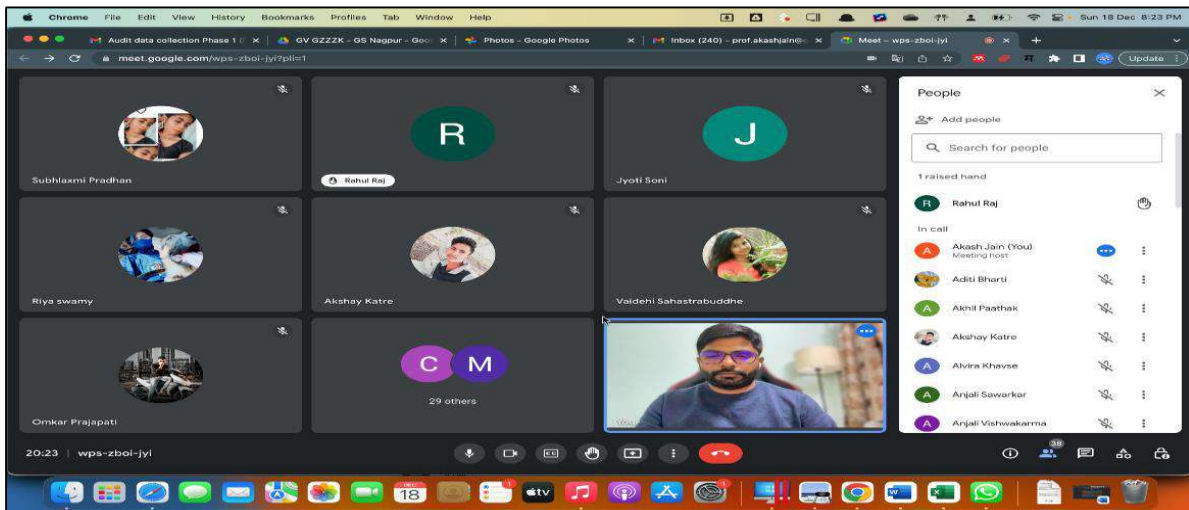

1. Discussion on Professional Etiquettes in Employment & Business - The following activity was taken for the students of Semester VI of all UG & PG courses (B.Com (Honours) & B.Com (Finance & Accountancy), B.Com, BBA, BCCA, M.Com, MBA) in Bajaj Bhawan under the Placement & Training workshop conducted by Placement Cell. This was basically taken to guide the students on what professional etiquettes are, how to dress up professionally, how to appear for interviews and how to communicate professionally. The topics were covered via discussion and practical teaching methods and involved participation of all the students. The purpose behind this activity was to make the students professionally eloquent and industry ready. The beneficiaries for the activity were 200+ students from the said classes.
2. Visit to the Audit Exhibition of CAG , Nagpur - The following activity was taken for the students of B.Com (Honours) & B.Com (Finance & Accountancy) , Semester II students where they were taken to the CAG office , Nagpur to see and understand the process of governmental audits , the financial statements etc. This visit was followed by a seminar by the CAG Office representatives on career options in Audit Offices of Government in our college, Bajaj Bhawan. This activity was basically taken to expose and enlighten the students with practical aspects of accounting and further audit and apart from that to give them a career orientation in a field unknown to them.
3. Discussion on entrepreneurship & how to scale a business - The following activity was taken for the students of B.Com (Honours) & B.Com (Finance & Accountancy) , Semester VI, under the International Finance subject. The students were encouraged to come up with ideas for start-up and show how they'll be earning a profit in the business through presentations. All the factors both internal and external which are key to the success of the business were discussed. The idea behind this activity was to encourage the students to explore their analytical mind and come up with ideas of scaling their business beyond the boundaries of India. The number of beneficiaries were 115 students from the said classes.
4. Discussion on historical perspective of Globalization - The following activity was taken for the students of B.Com (Honours) & B.Com (Finance & Accountancy), Semester VI under the International Finance subject. The students were asked to discuss in groups the history and evolution of the Global Economy. The number of beneficiaries were 115 students from the said classes.
5. Case Studies discussions on company law rulings for different corporates - The following activity was taken for the students of B.Com (Honours) & B.Com (Finance & Accountancy) under Company law and secretarial practices subject. The students were encouraged to research and then discuss the said topic. This activity was done to increase their practical knowledge. The number of beneficiaries for the activity were 76 students of the said classes.
6. Company Analysis - The following activity was taken for the students of B.Com (Honours) & B.Com (Finance & Accountancy), Semester IV, under the Management Accounting subject. The students were encouraged to research about the company & their financial position using ratios, cash flows etc. and a discussion on the same was taken in Bajaj Bhawan. The number of beneficiaries for the activity were 125 students of the said class.
7. Analysis of Balance sheet of corporate: Reliance - The following activity was taken for the students of B.Com (Honours) & B.Com (Finance & Accountancy), Semester I under the Financial Accounting subject. The students were encouraged to explore the different

components of the balance sheet and analyze the same. The beneficiaries for the activity were 93 students of the said classes.

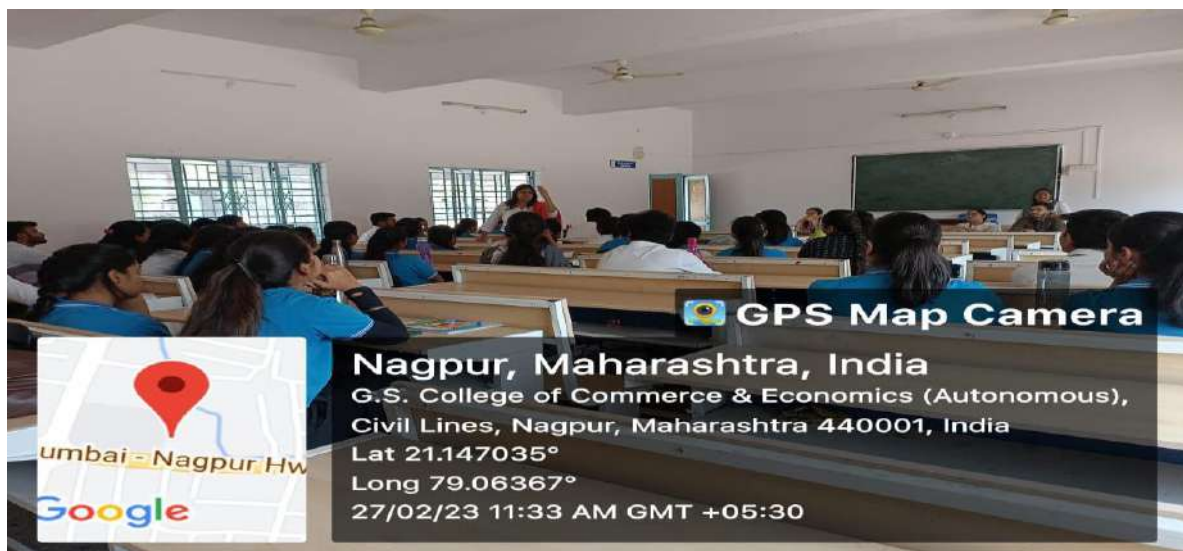

4. Workshop: Enhancing Communication Skills

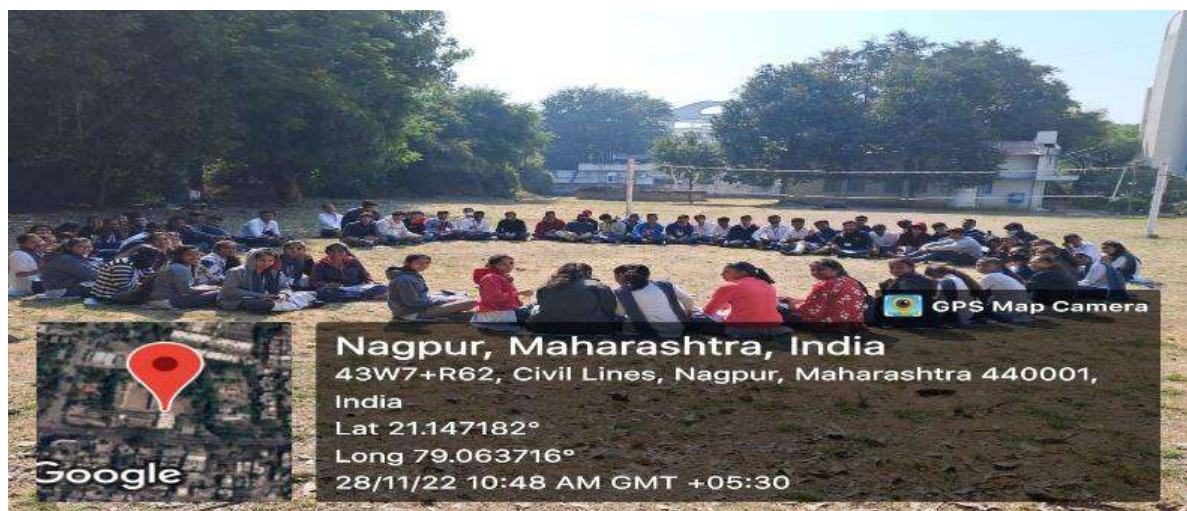

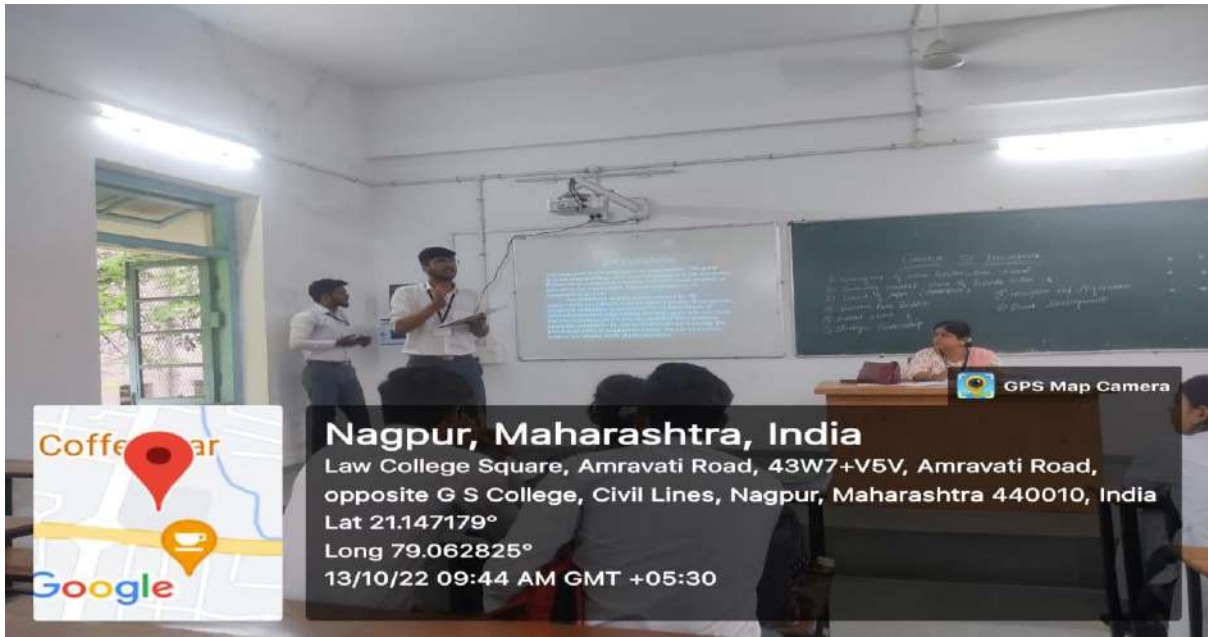
