### 1. Details of an Activity/Event:

National Stock Exchange, Mumbai every year organises Nation wide Live Stock Trading Competition inviting interested students and traders across India to trade and compete on a single platform. This competition is conducted on virtual trading platform i.e. **NSMART**. National Stock Exchange, Mumbai conducted a weeklong training programme to explain the use of NSMART for taking trades, booking profiles by squaring off the trades in different segments such as equity and F&O. The session is conducted by the experts from NSE. During the session they also addresses the queries of the participants very professionally.

After the training, the participants are given a time of couple of days to practice trading on NSMART Simulator. In NSMART, a virtual sum of money is given to participants, and they are required to invest this sum into various stocks, futures & options and make profitable trades from it. The trading activity continues for a week and after the week participants with higher profits are selected for the final round.

In final round, participants are required to explain the strategies they have used to take trades in the trading week and justify their trades in front of the panel of juries.

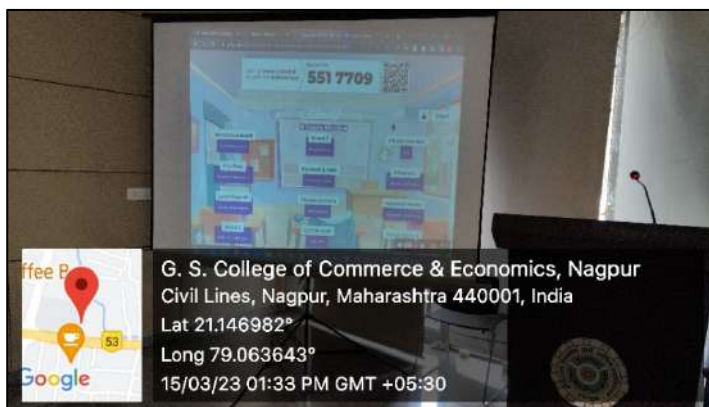
