**Direction No. 6 of 2023**

(REGARDING CARRY ON SYSTEM FOR ALL UG AND PG COURSES FOR ALL NON-NEP UG PROGRAMMES OF B.COM., B.C.C.A., B.B.A., B.COM. (HONORS), B.COM. (F&A) AND PG PROGRAMME OF M.COM. NON-NEP PROGRAMMES)

G. S. College of Commerce and Economics, Nagpur has been granted autonomy by the University Grants Commission (UGC) and the RTM Nagpur University, Nagpur, from the session 2018-2019 and from this academic year 2023-2024, the college is implementing New Education Policy-2020 as per the GR received dated 20-04-2023 and 16-05-2023 for all first year UG and PG courses except MBA. In view of the NEP curriculum & credit structure to be implemented for Sem-I and Sem-II from the session 2023-2024 the college has to design the policy for the failure students under Non-NEP curriculum.

Being an autonomous college, G. S. College of Commerce and Economics has the authority to design & implement the admission process for students who failed in the first year in the session 2022-2023 or in the previous academic years (Non-NEP), allowing them to proceed to the second year (Sem-III & Sem-IV UG/PG) by giving them option of Carry-On. Additionally, for the academic year 2024-2025, these students can continue into the final year (Sem-V & Sem-VI UG only) of their respective courses with same Carry-On scheme. Hence, the following Carry-On Scheme shall be operative w.e.f. 2023-2024 for all Non-NEP second year programmes (except MBA) and from 2024-2025 for all third year programmes.

- A) To overcome the academic loss of the Non-NEP students, the college has devised a policy called "Carry On." This policy allows students who have failed in some or all subjects or have not met the ATKT (Allowed to Keep Terms) requirements to seek admission in the second year for the session 2023-2024.
- B) For the session 2023-2024, students who have not fulfilled the ATKT rules, as defined in the college's regulations for all courses, are given the opportunity to secure admission in the second year.
- C) The students should fill the admission form for seeking admission in second year in the session 2023-2024 and third year in the session 2024-2025.
- D) Students interested in availing the Carry-On system must submit a hand-written application in favor of the Principal of the college expressing their desire to be admitted in the second year for the session 2023-2024 and the third year for the session 2024-2025. The application should clearly state the student's request for admission in the desired year and session. The application must include relevant details, such as the student's name, roll number, course, the name of the subject(s) in which he/she has failed in earlier semester and the reasons for seeking admission through the Carry-On system.

- E) The deadline for submitting the Carry-On application will be communicated by the college office. Late applications may not be considered, and the college reserves the right to reject applications received after the deadline.
- F) The decision to grant admission through the Carry-On system will be based on the student's academic performance and overall suitability. The college administration holds the authority to make the final decision regarding admission under the Carry-On system.
- G) Students who are granted admission through the Carry-On system will be notified by the college administration. The notification will include instructions regarding the fee payment and any additional requirements for admission.
- H) The students must complete the necessary admission formalities within the designated time frame and students are also expected to fulfill all academic requirements, attendance regulations, and any other obligations outlined by the college.
- I) This "Carry-On" scheme also extends to all students who have failed in previous years' autonomous courses/examinations.
- J) Students who do not apply for admission through the Carry-On system will not be considered under this scheme. The college will not be held responsible for the academic loss of students who do not avail the Carry-On system.
- K) The final result of such students will be declared after clearing/passing all the subjects of all the semesters.
- L) These Direction No. 06 of 2023 will be automatically nullified upon completion of the admissions of Non-NEP courses in the session 2024-2025.

This Direction has been approved by the members of the Academic Council and the Governing Body of the college.

**The Direction shall come into effect from the academic session 2023-2024 for all non-NEP Programmes.**
